Your application will only be used for the purpose of granting STUVO student financing. Third parties (such as teachers) do not have access to this data. If you wish to view and possibly adjust the data, you can do so by means of a written request addressed to VZW VIVES NOORD, STUVO for Brugge and Oostende or VZW VIVES Zuid, STUVO for Ieper, Kortrijk Roeselare and Torhout.

The application form must be submitted by June 1, 2026, at the latest.

Any additional study costs must be submitted by August 31, 2026.

The student applicant agrees:

- that STUVO may request information from other competent services;
- that STUVO treats my data confidentially: they are only used to determine whether I can receive student financing;
- to immediately notify STUVO of any changes in the financial and social situation. In that case, the decision to grant financing may be revised by STUVO;
- that any incompleteness in the declarations or any incorrect information may result in the termination of the payment and the recovery of the STUVO allowance;
- to notify STUVO in writing within one month of any address change;
- that if there are any outstanding invoices within the financial service (school invoices) or within student affairs (tuition fees), STUVO will prioritize the settlement of those invoices. The allowance will then not be paid into the beneficiary's account as described above, but into the VIVES account.
